Biographies

Corrado Malberti

Corrado Malberti is Associate Professor of Commercial Law at University of Trento since 2015. From 2010 to 2015 he was Associate Professor of Commercial Law at University of Luxembourg, where he was also director of the Master 1 in European Law. He graduated from University of Milan in 2000. He completed an LL.M. at University of Chicago in 2005 and a Ph.D. in commercial law at Bocconi University (Milan) in 2006. His principal research interests are national, comparative and European company law and financial market regulation. He has widely published in the fields of company law and financial market regulation in English, Italian and French.

Felix Steffek

Felix Steffek is a University Senior Lecturer at the Faculty of Law of the University of Cambridge and a Senior Member of Newnham College. He serves as Director of the Centre for Corporate and Commercial Law (3CL) and Director of Studies for undergraduate and graduate students. His research interests cover corporate law, insolvency law, commercial law, dispute resolution law and technology & law.

Felix Steffek is a Member of the Editorial Board of the Journal of Corporate Law Studies, the Cambridge Yearbook of European Legal Studies and other academic journals. He is a Member of the Education Taskforce of the UK LawTech Delivery Panel.

He has acted as policy advisor and expert for the European Commission, the European Parliament, the World Bank, the OECD, national governments, courts, parliaments and science foundations. He received his education at Cambridge (LLM), Heidelberg (PhD, undergraduate) and Hamburg (Habilitation, court clerkship).

Yuri Biondi

Yuri Biondi is senior tenured research fellow of the CNRS (IRISSO – University Paris Dauphine PSL) in Paris. Graduate of the Bocconi University of Milan (DES), of the University of Lyon (DEA, PhD), of the University of Brescia (PhD) and of the University of Paris I Sorbonne (HDR), he is founding editor of the Journal “Accounting, Economics and Law: A Convivium” and convener of the SASE Research Network devoted to “Accounting Economics and Law.” He is coordinator of the SIG devoted to 'Business and Financial Law' and Council Member of the European Law Institute (ELI). He was chairman of the Financial Accounting Standards Committee (FASC) of the American Accounting Association (AAA) from August 2011 to August 2013 (member since August 2010). His research interests include dynamic systems analysis; economic theory; corporate governance and social responsibility; financial, prudential and accounting regulation; governmental accounting and finances; sustainability, durable development, non-financial reporting and disclosure.

Thomas Papadopoulos

Thomas Papadopoulos is an Assistant Professor of Business Law at the Department of Law of the University of Cyprus. He received his DPhil in Law from the Faculty of Law, University of Oxford, UK (2010). He received a degree of Magister Juris-MJur (2006) and a degree of MPhil in Law (2007) from the Faculty of Law, University of Oxford, UK. He also received his LLB with Distinction (ranked 1st) from the Department of Law, Aristotle University of Thessaloniki, Greece (2005). Previously, he was a visiting researcher at Harvard Law School (2009-10). He is also a Visiting Professor at International Hellenic University and an Attorney at law (Greece). Moreover, he is an Editorial Secretary of European Company Law (ECL) Journal published by Kluwer. He was awarded the “Cyprus Research Award-Young Researcher (2014)” of the Research Promotion Foundation of the Republic of Cyprus (category of “Social Sciences & Humanities”). This distinction was awarded on the basis of his research on Takeovers and Mergers and was accompanied by a research grant. His main research areas are business law, company law, financial law, capital markets law, competition law, insolvency law, European economic law and internal market law. His articles were published in many top international law journals. He is also the author of the following monograph published by Kluwer: *EU Law and the Harmonization of Takeovers in the Internal Market, 2010, Kluwer*. Moreover, he is the editor of the following book published by Springer: *Cross-Border Mergers - EU Perspectives and National Experiences, 2019, Springer*.

Walter Doralt

Professor Walter Doralt is based at the University of Graz since 2019. He is currently a visiting Professor at the Université Paris II, Panthéon-Assas. He completed his “Habilitation” at Bucerius Law School (Hamburg, 2017; postdoctoral thesis on Long-Term-Contracts, published as a monograph with Mohr Siebeck in 2018 under the title *Langzeitverträge*). Until 2017, he was a Senior Research Fellow at the Max-Planck-Institute for Comparative and International Private Law in Hamburg responsible for French Law. In 2007/2008 he held a visiting position at the University of Oxford, Faculty of Law, Institute of European and Comparative Law (IECL) and in 2009/2009 a visiting professorship at the Università Bocconi in Milan. His doctoral degree was awarded by the University of Vienna (2005, thesis on Auditor independence and liability of auditors). Professor Doralt is a co-founder of the European Law Institute (ELI), an International Non-Profit-Association (AISBL) based in Brussels. He served on the ELI-Council from 2011-2019 (reelected in 2015) and also chaired its Membership Committee during that period. His main research interests are in Civil Law and Company Law, with methods drawing on Comparative Law and Law and Economics.

Katrin Deckert

Katrin Deckert is Associate Professor (Maître de conférences) at Paris Nanterre University, affiliate at the Hamburg Max-Planck-Institute for Comparative and International Private Law and former Deputy Secretary-General of the International Academy of Comparative Law. She studied law in different universities in France and Germany. Since 2009, she holds a PhD in German, French and European corporate and securities law from Panthéon-Sorbonne University (Paris, France) and the University of Hamburg (Germany). She was Research Fellow at Pantheon-Sorbonne University (2001-2004), research and teaching assistant at Panthéon-Assas University in Paris (2004-2006), Research Assistant at the Max Planck Institute for Comparative and International Private Law in Hamburg (2007-2009), Lecturer in German Law at Paris-Est Créteil University (2008-2010), and Senior Research Fellow at the Max Planck Institute for Comparative and International Private Law (2010-2011). She teaches and researches in German, French and European civil, corporate and capital markets law as well as in comparative law.

Anastasia Sotiropoulou

Anastasia Sotiropoulou est Agrégée des Facultés de Droit, Professeur de droit privé à l'Université d'Orléans et membre du Centre de recherche Pothier et du Laboratoire d'Excellence de Régulation Financière, ses recherches portent sur le droit des sociétés et le droit bancaire et financier”.
